

South-Tyrol Raiffeisenkassen: partnership with Nexi for the digitalization of public administration bodies

*South-Tyrol Raiffeisenkassen makes the new Nexi SmartPOS terminals available to local authorities in Bolzano Province for the collection of PA payments.
Tangible benefits for both public bodies and citizens*

Milan, 6th February 2023 – Raiffeisen Landesbank Südtirol AG, the central banking institution of the South-Tyrol Raiffeisenkassen, announces that it has signed a partnership agreement with Nexi, Europe's leading PayTech, thanks to which citizens will be able to pay pagoPA bills via payment cards and smartphones at all the bodies in the Province of Bolzano that will join the program.

Under this partnership, the Province's public administration bodies can request from the South-Tyrol Raiffeisenkassen the new Nexi SmartPOS terminals, the most technologically advanced devices on the market perfectly integrated with the PagoPA system, through which they can collect any type of PA bills: fines, healthcare charges, taxes, etc. This agreement guarantees tangible benefits to both public administration bodies and citizens - the former can optimize all collection processes, significantly reducing waiting times thanks to transactions taking under 15 seconds and thus guaranteeing a more efficient and effective service, and the latter can make payments to public administration bodies in a much more convenient, fast and secure manner using cards or smartphones in contactless mode.

For Raiffeisenkassen, the first bank in South Tyrol to make Nexi SmartPOS available to PA bodies, the agreement represents a further stage in their journey towards technological innovation, in this case aimed at supporting the public sector in its digital transition and guaranteeing real benefits for citizens.

The system is very simple - users need only scan the QR code on the PA bill and the amount due is automatically displayed on the SmartPOS terminal. At this point, they can finalize the payment by simply placing the card or phone close to the device.
